I, Ismail Rustem, would like to inform you that I shall commit suicide in front of one of the state organizations in Europe on **15 May 2009**. The place where I am going to do it I'll declare exactly in April. During this period of time I'll spread CD-s containing my protest to all countries of the world and their press. I will protest and demonstrate in front of the state organizations situated in Germany on Tuesdays and Thursdays of every week, give interviews to the European Court of Human Rights to reveal and expose the activities of the German police and doctors of the Federative Republic of Germany. I will not be forced to commit any crime.
