(The Court of European Human Right destroys a life.)

## APPLICATION

I want to clarify through my letter that Germany keeps me under the political blockade. The German State gave no residence permit for long years; I demanded and struggled for my rights and gained them after nine years. However, after I gained my permission, I had to fight against many political problems in Germany.

It has been proven that I am a successful merchant, but the German State do not allow me for trade and ignores my right of commerce, which is actually valid between 1998-2017. The social common rights like leisure facilities, working, politics and trade are made impossible due the blockade. In the country where I am virtually under house arrest, I have no possibility except for living under terrible conditions.

The German Courts admitted and accepted their failure of seven years in 2005. Because of their wrong decision, I suffer from 16 serious diseases. Therefore I am now physically 80 % disabled. One of these diseases is AIDS. With this acceptance, the other 30 courts which gave me punishment according to that wrong decision, share this failure simultaneously. In 2010, the local court in Berlin gave me nearly 100.000 Euro fine, instead of paying for my physical and moral damages. And the court could do it with the help of their own law counsellors.

In 2009, I applied for a law action for my damages by the court who accepted his failure. After 21 days from my application, the German court removed all my rights and gave to his law counsellors. And then the second political attack of Germany began. They left me again in a new physical and moral blockade, by using their counsellors. Because of the wrong consulting of those counsellors, I fled to Turkey for 6 months and I gave effort without any counsellor and proved by myself that I do not need a counsellor and Germany has political goals against me. Thanks to my efforts, the wrong decision was cancelled after 1 year; however I still must suffer from consequences of the counsellor and it continues till 2017. All conditions I provided such as internet, telephone, fax, law actions which proved I am right, especially the damages, my bank accounts etc. have been removed and banned intentionally by the counsellors. The court ignored my refusal and did not appreciate my demands on this issue.

I conveyed my law action for damages to the Federal High Court in Germany. The Court claimed that I can not carry out any action without a lawyer and demanded a retraction from me; otherwise the decision would be invalid. I demanded that the law gives me right to appoint a lawyer on 26.09.2011. For I was not replied for 11 months, I wrote again on 07.08.2012 and demanded for information.

On 10.08.2012, they answered and refused my applications for any law action. They also informed that they gave a judgement on 05.10.2011 and this decision was sent to me on 07.10.2011. This is not true! They try in this way to prevent that I refuse their decisions and they try that I accept their unjust judgement. I can not comprehend that three judges decide without listen to me or my lawyer.

It is not acceptable. The decision of the Federal High Court on 05.10.2011 (Nr. XII ZB 484.11) has arrived to my address in August 2012, after I insisted for a reply by writing my letter on 07.08.2012. That's why; I demand that the European Court of Human Rights takes my complainment into account. Otherwise, it is impossible to live under these conditions and the European Court faces an accusation of killing a man.

If the German State would give me all my legitimate rights today, then he is also obliged to explain it according to the ways and the years of these vested rights. I have received the residency permit after nine years; it was much effort and very exhausting. I have received my permission for working, only after I became fully disabled. Only after my name was registered in the Schufa (Credit Investigation Company), I received the permission for a work as self-employment, but I could no longer have this possibility because of the registration in Schufa. My application in 2004 to attend a language course was appreciated in 2005, after they had put me in a mental hospital because of psychological threats. I never got the chance to learn something, even not one time. I received the permit for travelling which allows me to go and see other countries, after I had financial troubles and I became heavily disabled. I demanded for a counsellor in 2004 because of unfair attitudes I experienced; it was appreciated by the authorities only in 2009 seriously, after I had legal rights. That was important; however did not help me either; but it went on supporting the injustice of the courts and organizations. On 05.02.2010, I finally received my disability card (80 %) which derived from my diagnosed diseases till 2003. Nevertheless, they wanted to give me no payment for pension, although they had crippled me. Instead, I was paid for the basic security help since November 2009. That means again that I can not leave Germany and I am not allowed to live in anywhere else. In addition, the funds for the vitamin (increased demand) which is necessary for each AIDS patient, was removed since January 2009 and the court (S 51 SO 1146/09) delayed the process of my case for 2 years. In my situation, you might have your funds for vitamin in your deathbed. But, it would not help me. This is an obvious attack on me and human rights! The German State does it in front of the eyes of UNO and the European Court of Human Rights shares it.

Although I did not commit any crime in this country for 14 years, I received unfair penalties by the courts and my commercial rights are banned through many obstacles till 2017. They even decided to take all my possible commercial profits. This destroys my life. They created many problems, so that they could reach their goal. They could do this by creating so-called crimes with the help of psychologists and some social and private offices and organisations.

After I wrote my complainment to the European Court on 01.04.2011 and on 10.09.2011, I posted my documents as proof on my web site [www.rustemazeri.com](http://www.rustemazeri.com). My web site was

banned illegally. Additionally I applied to the Amnesty Berlin, the German Parliament and the local Court. They ignore my attempts and it shows me they create political obstacles, so that they remove all my evidences such as videos and documents on my web site. Some videos on YouTube such Rustem Azeri 61/65 and 68 have been banned, too. I was defending myself against Germany in such videos. Some important letters which I have sent to foreign organisations even as registered mail do not reach the recipient and so proof of delivery never arrive. Also some of my very important emails do not reach the receiver.

I can prove with my documents that all accusations directed to me in 14 years have been done intentionally and illegally. And each of these accusations damaged my health and life. This proves that the AIDS disease was transmitted intentionally. However, the European Court of Human Rights did not permit me to prove it. The law action was opened four times in the first instance of the court, but no result. They bully and prevent me. Each time some excuses have been shown. I was stopped and banned to apply to a higher court. They destroyed all my rights in a rude way.

The German State knows that I can not resist to live in blockade all my life and I will refuse it, he uses his psychiatrists and professors and tried and tries to make the society confused. It is clear that such false diagnoses like crazy, paranoid and schizophrenia have been written illegally. A person who suffers from paranoia or schizophrenia could not have found the necessary approaches, like I did with a patience in worthy of esteem. But I still react very carefully for my vested rights. Of course, my patience will not continue forever.

Although I could prove all incidents, the German doctors with political purposes diagnosed me as paranoid; because state is the only organization which could be successful for such events. With this false diagnose, Germany shows two political aspects firstly, he swerves the real facts and make the psychological terror survive; secondly he wants to have benefits and profits of this terror which are seen clearly with the terrible results today.

The false diagnose about schizophrenia was written in 15 minutes after 5 narcosis and so I am also not allowed to refuse my blockade. If a schizophrenia patient refuses any blockade, they keep him in insane asylum by using an injection without a judgement.

This legal act was brought two years forward. Because I was sent many times in the past to an insane asylum by force and without reason and they tried to give me an injection. I refused it and began to do hunger strike and then the event was heard by public. Finally the court had to let me go. In this situation, they intended to use an injection on me, just because I insisted on my rights. Since many people noticed this situation, the court had to let me free.

If you compared the diagnoses of Fransizkos and Augusto Viktoriya hospitals from the dates 20.06.11 and 01.07.2011, you would see two different diagnoses. And you will see that I was not treated to AIDS purposely. The so-called schizophrenia diagnose was written not in a hospital for psychiatry, but in a hospital for the AIDS and for political interests.

With the help of this political diagnose, I was introduced and expressed in a wrong way purposely, so that I would be discriminated in the social area.

Like always, bullying is still going on. The aim is that I become exhausted, do suicide or go crazy. I demand for help from the Azerbaijan Embassy, Amnesty Berlin, AIDS Organization Berlin, Red Cross Berlin and other organizations for human rights and finally German press; they always throw me out politely. That means that I must live alone all over the world and

remain in this blockade. Because Human Rights Organizations help the people in other countries, if their rights are vandalised. But in this country, it has been proven that organizations do not help me. I wrote and talked many times in such organization since 2002. But they ignore me, so as to protect their state; they call me liar and throw me out. When the court corrected his decision about 7 years in 2005, he simultaneously confirmed that I am right but those organizations not. That's why; Human Rights Organizations do not want that these unfair and shameful mistakes are heard by public. All Organizations want to cover up this failure like the courts.

If you investigate the support of German human rights organisations on racism you will see that a lot of immigrants suffer psychological illness and commit suicide. I am sure that they do not come to Germany to commit suicide.

The German State is responsible for all these mistakes. The German judgement, police, doctors and many organizations have been unjust, did wrong to me and make me suffer from such heavy diseases. They have thrown me to the streets and I got sick. I was desperate without any help. I state again that the laws which in order that they should help me have been ignored and destroyed by the courts.

There is a common law in the world; if a court admits his failure, he must pay to the person for his/her moral and physical damages. In contrast, I made them admit their failure, I suffered from damages and however I also had to pay for their damages. I received house arrest for the whole life, my life will be destroyed. hy

For all those mistakes, the German State provides only some food and I must stay in Germany. They do not want me to go anywhere else in the world; they do not allow me to go, because they do not want that I share my experiences with the world. Germany knows he fell into error, that's why he is obliged to allow me to live where I want and free and he must provide for all my needs.

1) I need 10-15 years to struggle alone to win this war. But I would not live so long because of my diseases. 2) If I accept the situation, I should live suffering under the house arrest. That makes me insane. If I struggle or not, it does not matter, both ways are like a death by torture. This hopeless situation forces me to suicide silently. That will be murder of the German State and the European Court of Human Rights. I ask the United Nations Organization to intervene in this process and make the European Court of Human Rights to hear my case.

I can prove all things I claim and all mistakes of the courts. I have evidences for that.


According to United Nations Organization, it will be a massacre, if people die or go insane because of blockade.
