Mr. President **Dean Spielmann**,

i received your letter and i try to prepare all documents as you suggest. Please note that my first head of claim is not from 24.04.2013 (**Application no. 32856 / 13**) but much earlier. All the informations are in my letter from 24.04.2013.

I want to mention that I am not a lawyer and it is very difficult for me to fulfill all of the formal conditions of the legal process. I had problems to find a lawyer, who could help me but know I found one in Strasbourg and I will meet him soon.

My case contains more than **7.000** pages of legally material. Its takes time to view and evaluate this material and summarize it for you.

That's why I request for an **extension** of the deadline to reply to your questions until

30.09.2013.

Please consider that this process is not easy for me because I suffer from 16 different diseases like **AIDS** and I am **80 %** disabled which were caused by an inhuman treatment by germany. German officials refused to grant essential medical treatment for years. I would like to have an open court hearing now to explain what happened because a lot of important informations are not in the documents but they are in my mind. I can not live anymore like in the past years as a victim who suffered from injustice. If I have don't have a chance to present the evidence and arguments and if I don't get help from your court I don't know how to continue my life.

Dear President of the European Court for Human Rights, Mr. Dean Spielmanns,

The complaint is hereby given that the German court (Nr.: 528 Qs 49 / 03) - (Nr.: 251b / 251a Ds) 52 Js 7 / 00 (349 / 00) has officially admitted its 5-year guilt and thereby reaffirmed the erroneous judgments adopted by 30 other courts within 7 years. It is the consequence of these judgments that made me an officially recognized invalid. In conformity with the law and proceeding from the fact that these courts admitted their erroneous judgments, I demanded to repair a damage I suffered. Following my demand on repairing damage, I have been victimized by the German state and fell victim to illegal political games. As a consequence, instead of being indemnified for losses, I was fined 91, 456 EUR. Total amount of illegal fines imposed on me exceeds some hundreds of thousands EUR. Instead of removing these disgraceful practices, the German state is engaged in persecuting me for 14 years, hence, I fell victim to these repressions. This notwithstanding, I managed to get my indemnification claims considered at all German courts ((Nr: XII ZB 484 / 11) - (Nr: 6 W 44 / 11) (Nr: 86 O 633 / 09)). The last judgment (Nr: XII ZB 484.11) of the Supreme Court of Germany (BGH) was adopted on 12.09.2012. (a copy of judgment attached). Following this judgment, I lodged a complaint to the ECHR. My letter to the ECHR dated 29.10.2012 says that my complaint meets the requirements of Article 35 § 1 of the Court of Appeal (a copy of the letter dated 18.01.2013 attached). This notwithstanding, I have not yet received an answer from you so far. This is contrary to the laws of the ECHR!!! Your devil-may-care attitude to my complaint is none other than flagrant violation of my human rights and damages me psychologically.

Should thousands of official documents I dispose of be properly investigated, you'd see that the German state has for 14 years been engaged in scheming against me in financial and documentation questions, creating illegal problems. In so doing, the German state is eager to suppress me, and provide me with no opportunity to freely choose a country where to live in independently. Psychological terror of this sort causes me a spiritual damage, gives me no opportunity to create a family, do a business and make a career!!! For this reason the only way out of impasse is to

demand from you to consider my complaint to the ECHR and adopt an appropriate decision on the subject. You are kindly reminded of the fact that my complaint has been lodged to the German parliament and all degrees of jurisdiction, and I insist that my complaint should properly and impartially be considered and honored by the ECHR irrespective of religious belief, language race to comply with human rights legislation!!!


I'll email you a video-recording of another person to demonstrate how the German state is creating a mechanism to annihilate citizens of foreign countries.

If you try to whitewash the German state and turn aside from considering my complaint referring to various judicial stratagems, I'll have to appeal to great powers, international mass media, courts and organizations and provide them with all documents, video- and press-materials, including gross violations of human rights of foreign citizens in Germany, as well as documents that testify to the policy of annihilation of foreigners in this country. Furthermore, I intend to provide great powers with facts and documents available against ECHR inactivity. I believe that as a structure designed to protect human rights you won't besmirch your authority and reputation in an effort to advocate criminal interests of this state and act as a puppet of Germany!!!

This is to inform you that I have no personal enemy; hence, the German state and the ECHR only are guilty of all my misfortunes and torments!!!

How an Azerbaijani was tortured in Germany

Our editors received a copy of an appeal of a citizen of Azerbaijan residing in Germany for 14 years, Ismail Rustem, b. 1970, native of Geychay, to the President of the Azerbaijan Republic, Mr. Ilham Aliyev of March 19, 2013.

With his residence permit in Germany, our fellow-countryman had later fallen into clutches of repressive apparatus of the German state, served his sentence in this country, was mercilessly beaten, tortured; sustained injuries, got infectious disease, humiliated and persecuted and finally tried to commit self-immolation as a sign of protest. For 14 years he has been engaged in struggling against the German state apparatus to protect and redeem his infringed rights. Repeated appeals to all instances of German judicial system yielded no desirable result. Suffice it to say that over 7 years Ismail Rustem has lodged 30 claims to various judicial bodies, some of the latter had to recognize legitimacy of his claims and invalidation of previously adopted decisions, especially a decision of the Supreme Court (BGH) g (Nr.: XII ZB 484.11) dated 12.09.2012.



In conformity with the existing legislation and under a decision of the court that admitted its mistake, I.Rustem lodged a claim of compensation for damages, following which he came to be persecuted by the German government. Instead of satisfying a court judgment and compensating for losses, the German government decided to fine him for Euro 91,456. At present, the sum of ungrounded debts imposed on our compatriot makes up Euro hundreds of thousands.

A month after a decision of the Supreme Court he lodged a complaint to the ECHR protesting against actions of the German government and, without waiting for his complaint, he sent a letter on March 12, 2013 to Din Spielman, chairman of the ECHR which demanded from him to perform his direct duties to protect human rights regardless of color and race, nationality, citizenship and political preferences. At the same time, I.Rustem believes that the European Court, in an attempt to protect interests of Germany, not only violates human rights protection obligations, but also causes irreversible damage to its image. I.Rustem accuses the European Court of protecting interests of the country that is allegedly a stronghold of democracy. Note that newly independent countries follow the example of Germany and adopt its principles of liberalism. In the meanwhile, Germany has for many years been waging war against unhappy emigrants, destroying their life, career, business, damaging them morally, terrorizing them in every sense of the word. If his complaint is dismissed, I.Rustem reserves the right to appeal to all international organizations, judicial authorities, international press, governments of other powers, provide them with facts and documents regarding other persons who are facing illegal actions on the part of the German government. Note that these documents may help solving a mechanism of the German policy of murdering immigrants, etc.

In his appeal to the President of Azerbaijan, I.Rustem, with reference to Article 53 of the Constitution of the Azerbaijan Republic - «the AR safeguards and stipulates for legal protection of Azerbaijani citizens, residing temporarily or permanently outside its territory», - kindly asks the President to call the Foreign Ministry of the AR and other state bodies to perform their duties and protect and reinstate infringed rights of Azerbaijani citizens.



An eloquence testimony to the inhuman policy of the German government in respect of persons of non-indigenous nationality and the human rights violation in Germany is today's statement of Harry Murray, chairman of the branch of the Human Rights Protection Union of Germany. He believes that censorship and even repressions against dissenters are typical for

Germany: «At present, Germany claims to lead the world. That's not a bad idea. However, for this to happen, the freedom of speech is cancelled. One may write about the foreign policy in Germany. Any German journalist would say this topic is absolutely open. However, materials published cannot affect interests of Germany. For example, one cannot touch upon facts of human rights violation. For the first time you are warned in an amicable way. Your editor, acquaintance or drinking companion says: «Break». If a journalist fails to understand, his contract is terminated and the journalist is dismissed. In so doing, Germany does not comply with a rule «thanks to this home, let's go to another». A journalist gets «a blacklisting» and will find no job in a country's newspaper, from Berlin to Hamburg. Should a journalist proceed with his struggle, his relatives would face difficulties. Thus, they'll be maltreated at work, school, etc.

Yes, there are national editions issued by the Turkish and Russian diasporas. However, materials published in these editions are none other than publications in a Moscow-located Azerbaijani district newspaper. Even worse, dismissals may be followed by search and inconceivable penalties. If you are not a native of Germany, you are sure to be ousted from the country. Another variant: you may be debarred from getting a job or, even worse, be nailed on charge. True, no killings in Germany are committed in the dark corners. Yet, that's no help!



Harry Murray maintains that "injustices in Germany are shouted about everywhere, except for the German press. It was a well-known report of the representative of Azerbaijan (surely not the world's leader in democracy and liberal values), journalist and human rights activist Eynulla Fatullayev «The Decline of Europe» that factually proved the recession and crisis of democratic values in one of the world's advanced countries".
