Germany refused essential medical attention for years (1998-2003) so that I developed many illness.

Since 2003 I try to bring my case to the European Court of Human Rights (Nr.: 746 / 04 – Nr.: 6859 / 08 - Nr.: 2968 / 09 - Nr.: 11399 / 10) but they refuse to accept my complaint. 2013 they (Nr.: 32856 / 13) accepted my complaint but they gave me too short time to explain what happend. I have no money and I am desperately ill so that i can not pay a lawyer who could institute the legal proceedings in legal permissible way. I need help to get justice. But I dont get the help in germany and I dont get help from Azerbaijan.

If i dont get the chance to defend against the injustice and if the European Court refuse to help me I have no other choice then to go on a hungerstrike (**26.09.2013**) and end my life.
