I have a very short life left due to 17 terminal diseases such as **cancer**, **diabetes**, **tuberculosis**, **chronic prostatitis**, **coronary ( infakt )**, **hepatitis**, **AIDS** etc. Despite of this fact, I can't stroll on the streets like a FREE man, live in a country where I would like to, choose a doctor I want and receive a proper treatment, because of the Germany's applicable laws of today. They are taking my **FREEDOM** away from me by restricting my treatment and committing murder. European Courts haven't been showing enough care to my cases ( **No. 2968/09**)- ( **No. 6859/08**)- ( **No. 746/04**) and sustaining them for almost 7 years. As a result of 17 cureless illnesses along with **AIDS**, I can't stand any more since they are **creating new barriers against my treatment every day**. I can't **afford buying my medication any more** because of the **psychological terror**, **blackmailing**, **cruelty**, **poverty** I am going through!!! **If they don't stop this cruel breach of my rights, injustice in a very short time, I will try hunger strike or maybe commit suicide for the sake of MY RIGHTS and FREEDOM!!!**

**NONE OF THE EVIDENCES GERMANY HAS BEEN COLLECTING BY COERCING ME FOR YEARS, DENYING ME MY FREEDOM, BLACKMAILING AND APPLYING PSYCHOLOGICAL TERROR CAN BE CONSIDERED VALID AS PER THE LAWS !!!**

I would like to draw your attention to the fact that Germany is a country which had driven **thousands of foreigners** to committing suicide in the last **10 years**, denies **FREEDOM** to the **millions of the foreigners** who are living there today!!! Their aim is very simple.... They receive **€ 35,000** for each refugee living in the country from the World Bank, and we all know that they don't even spend **€ 5.000** per capita for their welfare. Just multiply this **€ 30.000** by **MILLIONS**, then you will understand their aim better. The foreigners like us, they let us do the dirtiest and the hardest work for them against a salary which a person can hardly live with for years without granting any work or residence-permit. **Slaves**, that is what we are for them. This way, they can avoid paying social insurance, invalidity indemnities etc. for their workers. That is the applicable laws they have been using to achieve this modern slavery. But, let's keep in mind that they need us since **70 %** of their population is consist of old people, and only **30 %** is young. They can't survive without labor force of foreigners. Despite to this fact, they still insists not to grant work permit to the **MILLIONS** of foreigners living there, don't they? According to the Human Rights Laws of European Union, it is a crime to restrict the **freedom** of the people, holding them **captives** and driving them to committing suicides. It is a **CRIME TO HUMANITY!!** Over **1000** Refugees had committed suicide in the last **10 years** in Europe because of the reasons mentioned above, and **none of them had come to this country to commit suicide!!!** There are laws in Germany causing people **die** and restricting **FREEDOM**.

If you turn me down or cover their crime up, i will have no other option left except committing suicide !!! Is the murdering of **1000** refugees an ordinary event ? Have these people come to Germany to die? Couldn't they die in their own countries in peace ? Have the United Nations and Amnesty International covered these suicides because these **1000** lonely refugees were insane and unbalanced people ??? Wasn't i sentenced to death because of court verdicts which held me captive in Berlin?**

As I dont speak English, I ask you to answer me in Azerbayrischan, Russen and Turkish
