## **Complaint:**

**To whom it may concern,**

My name is Rustem Ismail. I was born 1970 in Azerbaijan and came to Germany in 1998. I am writing to you regarding my life situation in the Federal Republic of Germany (FRG) and asking you urgently for help.

I am living in bondage since I came to the FRG and it seems that this will last until I die.

To make it short, but imaginable:

The day after my arrival ( 1998 ) I was caught by the police. They imprisoned me because they wanted to deport me. I was ill and nobody cared about it. Furthermore, I was beaten by the policemen ( date 2nd November 1999 ) in prison due to the fact that I asked for medical aid. Five years I did not receive the necessary medical treatment and lived nine years in Germany with the wrong status. The German court ( **AZ.: 528 Qs 49 / 03 ( 251 b / 251 a Ds ) 52 Js 7 / 00 ( 349 / 00 )** ) confessed its mistake after this nine years. They wanted to let pass time which was against my interests, making it harder to provide proof. So it is obvious that the decisions before were also wrong ( around 80 lawsuits in total ).

As a result of that I am seriously ill and disabled today ( 80 % ). I am suffering from cancer, one of my lungs is ruined, I am infected by the HIV Virus and I have fourteen other diseases. In FRG I received medical aid not before I was beyond remedy and I got a work permit after I was incapacitated.

The FRG tries to muzzle me and wants to cover up there crime against humanity.

I need the help of an international expert **NATO** who independently analyzes all documents ( [www.rustemazeri.com](http://www.rustemazeri.com) ).

What Germany offers to me now is a so called "Grundsicherung" ( basic financial security ), I got a permit of residence, but I am not free to leave the country and live elsewhere in the EU.

After all that happened I need financial aid - I am unable to work -, but I definitely want to leave the FRG.

I have nothing else to accomplish my freedom than to stop swallowing my medication against all my diseases, even the HIV Virus ( started date 2nd April 2010 ) and I am intent on doing so since somebody helps me. I am asking the **NATO** and the **European Court of Human Rights** to effect a court order which allows me to live - financially supported - anywhere I want to in the EU, but not any longer in FRG.

I want to file an objection against the ruling of the International Court of Human Rights of 07.10.2010 (Nr. 2968 / 09) - (Nr. 6859 / 08) - (Nr.746 / 04), saying that my my plaint may not be tried, and I now, that the second Instant say jess to my Problem. My human rights and my freedom remains still being disrespected and, as far as I am at the mercy of the German jurisdiction on bondage, the International Court is not competent to try this affair.

The courts of Germany have, without informing me, imposed a money fine on 05.10.2010 amounting to 91 456, 00 EUR. I just came to know this in December 2010, when the authorities appeared in my flat to seize my personal belongings. In addition, another German court of jurisdiction, again without my knowledge, imposed a fine on me that lead to the bank closing my bank account, where each month my social benefits are being paid. Thus, I am being deprived of every chance to leave Germany, as I am to 80% disabled, suffering from 17 physical diseases, but without money one cannot survive anywhere.

My person in support also filed a complaint in court against me, because I did not give him the permission to pay money from my account that is meant for me to buy foods and paid by the Social welfare office, to other people. I wanted him to sue other persons before court, who were drawing money from my account, what he did not want to do.

All this proves once again that I am a person, who is still being treated against the laws in Germany and it seems that this is going to continue for life. They want me to remain in bondage and ignore my human right of freedom.

German courts issue decisions, stating that I was mental, without medical expertise and opinions. They are trying to convince me that I was a criminal and are so pushing me to commit suicide. I need the intervention of **NATO** experts to help me obtain my freedom from bondage.


I am sorry for being so demanding and also I excuse my lack of fluency.
