Appeal to the World States

I, Ismail Rustem, would like to inform you that I shall commit suicide in front of one of the state organizations in Europe on **15 May 2009**. The place where I am going to do it I'll declare exactly in April. During this period of time I'll spread CD-s containing documents to all countries of the world and their press. I will protest and demonstrate my position by means of slogans in front of the state organizations situated in Germany, Europe and other countries on Tuesdays and Thursdays of every week, give interviews to the journalists mainly claiming the European Court of Human Rights to reveal and recognize the crimes of the courts, officials, police and doctors of the Federative Republic of Germany against me. **If the German state creates any obstacles preventing me from pursuing my rights through democratic means, i will be forced to commit suicide immediately in front of some state organization.**

My claims are:

1. to replace me urgently to another country of Europe and start the medical treatment;
2. my case must be tried in a high chamber of European Court of Human Rights;
3. experts from neutral countries must be defined in order to reveal the reasons and the timing (dates) of my illnesses;
4. my freedom must be restored;
5. the criminals must be punished;
6. my material and moral losses (50.000.000 euro) must be compensated.

After my death all my rights automatically transfer to my family members. I have certified this will in the High Court Notary (9101 E/F 284/08 , 9101 E/F 285/08) of the Federative Republic of Germany.

The reason of my self-murder is the violation of my rights by the courts, police, doctors and officials in Germany. Instead of treating my diseases they wanted to hide them. During the years 1998 and 1999 the state bodies of the Federal Republic of Germany violated my rights many times, as a result of which I got very ill. For example, in 1999 the german police had forced me to take off my clothes and beaten me in a naked form. This was a clear breach of my human dignity.

Afterwards since 1998 till 2008 some german courts took judgements, which were absolutely contrary to human rights. **With a clear intention** the german courts made me through such decisions to get ill both mental and physical. And this is how i have got 16 severe diseases.

One of the essential reasons of my suicide is associated with the fact that in both of my two cases (746 . 04 and 6859 . 08) considered by the European Court of Human Rights without my presense and my lawyer's awareness as well, it was decided not to hear my claims because as was explained they can consider my case only after the adjudication of the Supreme Court of the

Federative Republic of Germany. But there have been already 11 decisions made by that Supreme Court of the Federative Republic of Germany (Bundesgerichtshof Nr- XII ZB 131 / 08 ; Bundessozialgericht Nr- B 8 AY 4 / 08 S , Nr- B 8 AY 2 / 08 AR , Nr- B 8 SO 13 / 08 AR ; Bundesverwaltungsgericht Nr- BVerwG 1 ER 126.07 , Nr- BVerwG 1 ER 128 / 08- ; Bundesverfassungsgericht Nr- (AR 45 27 / 07) -1 BvR 2918 / 07 , Nr- (AR 3301 / 08) - 2 BvR 2067 / 08 , Nr- AR 6660 / 08 , Nr- AR 6429 / 08 , Nr- AR 7530 / 08). What a just judgement can I get in Germany if the traces of crimes of 70 court cases have been concealed over the last 10 years and taken into account that there are only 3-5 years left for me to live more?

The European Court of Human Rights knowing that this case can lead to a death outcome, has put me face to face with German state, completely ruining my life. This European Court of Human Rights tries a case after a person's death because the dead can neither speak nor defend themselves. In such case, it is very easy to accuse them in anything. While I am alive I can prove my case, but after my death the German state does not have a right to defend itself.

German courts were forbidding me to go to a doctor for 5 years. In result of these law violations I have **16** different illnesses now. " 1) Z.n. Lunge tuberculoses, 2) Depression, 3) AIDS Infections, 4) Z.n. Myokarditis (Infarct), 5) Prostatitis chronic, 6) Refluxösophagitis II, 7) Hepatitis A chronic, 8) Z.n. Lues II (Sufflis), 9) Hemorrhoid, 10) Vitamin B 12 Mangelamämie, 11) Erosive Pan gastritis chronic, 12) Somatisierungsstörung, 13) Asthma Bronchitis chronic, 14) Perniziose Anemia, 15) Z.n. Ulkus ventriculi, 16) schwere Seelische Krankheit - (Heavy Mental illness) "

I was allowed to participate just in seven court hearings. As I was proved to be right in those 7 hearings, my opponents got difficulties to prove their positions and decided to postpone the decisions for the days when i was not allowed to come personally and the hearings, where it it was easy to accuse me, were again occurring without me. In the other 63 judgements I have been judged illegally without my presence and without getting any right of defence. In the end unjust judgements supporting criminals' interests were made. I can prove you that German state and the judges are guilty in all the crimes against me and they ignore me in order to conceal all these processes.

Since I am not employed and get the social support, according to the German law, the state has to pay for the lawyer and other expenses connected with the court. All German courts illegally rejected me in this right. If the court process fee is not paid, this automatically means the case won't be considered. Just only these decisions about court rejections are already enough to prevent the crimes from the revealing. If those courts did not made me disabled (**invalid person**), i could work and pay for the exercise of my rights myself.

As I'm suffering from 16 illnesses, there are only 3-5 years left for me to live. German state illegally hasn't allowed me to live outside of Berlin for 9 years. In the court with great difficulty I could prove my case and in this way I could achieve my "freedom". But instead of giving me pension, the German officials diverted me by rendering little "help", which obliges me to be outside of Germany not more than 21 days per year. In other words, they have again taken my freedom away by doing so. If i was receiving pension, I could reside all the time abroad almost
